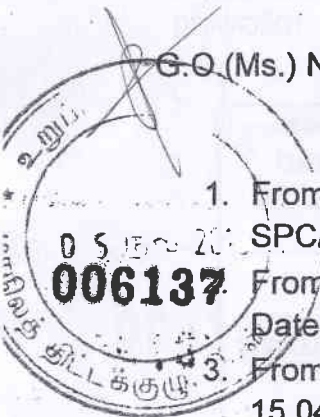

ORDER:-

In his letters third read above, the Director of Agriculture has stated that the Tamil Nadu is focusing on increased adoption of cost effective and eco-friendly cultivation practices for which bio-control agents are produced through Government owned 10 bio-control labs & 2 Integrated Pest Management (IPM) Centres and distributed to the farmers at subsidized cost through Agriculture Extension Centres. The IPM centre at Kancheepuram is one such lab that produces and distributes bio-control agents particularly, 310 litres of Nuclear Polyhedrosis Virus (NPV) every year which could cover only 5% of the cultivated area of paddy, pulses and oilseeds in Kancheepuram, Tiruvallur and Cuddalore districts.

2. He has further stated that NPV is self-perpetuating, safe to natural enemies due to host specificity, environmental friendly, less residual toxicity, compatible with many chemical pesticides and can be implemented as one of the major components in IPM programmes. It also facilitates healthy growth of crops thereby increasing the yield by 20 to 28 per cent. Hence it is programmed to focus on bio-control of pests through mass production and distribution of NPV (500 lts) for foliar spraying to control the diseases & pests in an eco-friendly manner. He has further stated that existing machineries in that IPM Centre are of 14 years old. As these machineries have become obsolete and unfit for increasing the efficiency and capacity, it is imperative to replace them with new ones and this will help to increase the capacity three-fold which will enable to increase the coverage from 5 percent to 25 percent.

He has therefore requested to sanction a sum of Rs.44.15 lakh for promotion of Organic Farming through Intensification of Bio-Pesticides Production for the year 2015-16. Further, the Director of Agriculture has stated that the Buildings and electrical work has to be handed over to the Public Works Department of the state for the execution. In this regard, he has submitted the copy of rough cost estimate for the work of proposed construction of Central Integrated Pest Management Centre at Panjupettai in Kanchipuram District given by Public Works Department, Kanchipuram. So, he has also requested to authorize him to draw and disburse the amount of Rs.31.50 lakh to the Public Works Department of the State.

3. The Government, after careful consideration, accept the proposal of the Director of Agriculture and sanction a sum of Rs.44.15 lakh (Rupees forty four lakh and fifteen thousand only) for promotion of Organic Farming through Intensification of Bio-Pesticides Production in Kancheepuram district under the following components:-


