ORDER:

In the letter first read above, the Member Secretary State Planning Commission has stated that the proposal of generation of enriched bio-gas as an alternative fuel for Corporation vehicles in Thoothukudi Corporation at an estimated cost of Rs.134.00 lakhs has been recommended by the State Planning Commission, for funding under Part-II restructured new innovative fund scheme "**Tamil Nadu Innovation Initiative (TANII)**" for the year 2015 –2016.

2. In the letter second read above, the Director of Municipal Administration has sent necessary proposal along with Detailed Project Report to the Government and requested to release a sum of Rs.134.00 lakhs as grant under the fund Tamil Nadu Innovation Initiative 2015-2016.

3. The Government after careful examination of the proposal of Director of Municipal Administration accord sanction and release a sum of Rs.134.00 lakh (Rupees One Crore and Thirty Four lakh only) towards implementation of the proposal of generation of enriched bio-gas as an



alternative fuel for Corporation vehicles in Thoothukudi Corporation under Tamil Nadu Innovation Initiative -2015-2016.

4. The amount sanctioned in para 3 above shall be debited under the following head of account:
