ORDER:-

In the letter first read above, the Member Secretary, State Planning Commission, has conveyed its recommendation the project cost of Rs.9.00 crore for purchase of 6000 Motorized Jacquard Machines for Handlooms at a cost of Rs.2,25,00,000 per year for next 3 years at the rate of 2000 machines per year. As an Innovative Initiatives on 75:25 basis to be shared between the Government and Beneficiary / Weavers Cooperative Societies.

2. In the letter second read above, the Director of Handlooms and Textiles has stated among others that they have proposed to purchase Motorized Jacquard Machines for Handlooms in order to promote the sale of handloom products in domestic and international market, designs have to be updated periodically according to the changing trends in the market. Hence, it is necessary at this stage to introduce new technology in the industry, so as to improve the quality of weaving and production. Motorized Jacquard Machine is one of the new accessory developed for Handlooms and it is easy to install and with almost no maintenance charges. The Director of Handlooms and Textiles has also furnished the advantages of Motorized Jacquard Machine as follows:-

Advantages of Motorized Jacquard Machine

- Low Power Consumption of 180 Watts.
- Less Weight up to 40kg only.
- It occupies Low space.
- Soundless Device
- Easy to Install (Weaver's may install)
- No maintenance Charges.
- Low Price Devise (1/3rd of the Compressor's Price).
- No Depreciation.

- Double Operating System (Intermittent function and continuous rotating function).
- Electricity Bill for 2 months is lesser. The tentative cost for purchase of one Motorized Jacquard Machine is estimated to Rs.15,000/-. The cost will be borne by State Government and Beneficiary/Society Contribution in the ratio of 75:25. It is proposed to purchase 6000 Motorized Jacquard Machines for Handlooms over a period of 3 years, for which, financial assistance to the extent of Rs.900.00 lakhs is required. The State Government contribution Rs.675.00 lakhs and beneficiary Contribution/Society contribution Rs.225.00 lakhs.

3. The Director of Handlooms and Textiles has requested the Government to issue necessary orders to approve the project for purchase of 6000 Motorized Jacquard Machine for Handloom for Rs.900 lakhs over a period of 3 years on 75:25 basis between the Government and Beneficiary / Weavers Co-operative society and requested to sanction Rs.2,25,00,000/- in the first phase under State Innovation fund towards State Government contribution for purchase of 2000 Motorized Jacquard machine for Handlooms for the year 2015-2016.

4. The Government after careful consideration accept the proposal of Director of Handlooms and Textiles and issue the orders in-principle for purchase of 6000 Motorized Jacquard Machines for Handlooms at a total cost of Rs.9.00 crore (Rupees Nine crore only) from "State Innovation Fund" and the cost has to be borne by State Government and Beneficiary/Society Contribution in the ratio of 75:25 as detailed below:-

5. According to the orders issued at para 4 above, sanction is accorded for a sum of Rs.2,25,00,000/-(Rupees Two crore and twenty five lakh only) as State share in first phase under Tamil Nadu Innovation Initiatives Schemes for the purchase of 2000 Motorized Jacquard Machines for Handlooms for the year 2015 -2016.

6. The amount sanctioned in para 5 above shall be met from the State innovation fund and debited to the following head of account:-

"2851-00. Village and Small Industries -103. Handloom Industries -II. State Plan - LF. Purchase of Motorized Jacquard machines for Handlooms - Schemes under State Innovation Fund - 09. Grants-in-Aid - 03. Grants for Specific Schemes"
