**ORDER:**

In his letter first read above, the Managing Director, Tamil Nadu Civil Supplies Corporation has requested for establishment of Solar Energy System at 169 Fair Price Shops, 200 numbers of godowns and at 21 Modern Rice Mills at a total cost of Rs.971.75 lakh under Tamil Nadu Innovations Initiatives Scheme.

2. In the letter second read above, the State Planning Commission has recommended to establish Solar Energy Systems initially in 70 selected godowns at an estimated cost of Rs.273.00 Lakh (Rupees Two Crore Seventy Three Lakh only).

3. The Government after careful examination, accept the above proposal and accord sanction for a sum of Rs.273.00 Lakh (Rupees Two Crore Seventy Three Lakh only) for establishment of Solar Energy System at 70 numbers of Tamil Nadu Civil Supplies Corporation owned godowns under Tamil Nadu Innovation Initiatives (TANII) for the year 2015-2016.

4. (i) The expenditure sanctioned in para 3 above shall be debited to following head of account.

5. The Principal Secretary/Commissioner of Civil Supplies and Consumer Protection Department is the Estimating, Reconciling and Controlling authority for the above new Head of account opened at para - 4 (ii) above.

6. The Pay & Account Officers/ Treasury Officers are requested to open the new head of account in their books.

7. Necessary funds have been included in the First Supplementary Estimates 2015-2016.

8. The Principal Secretary/Commissioner of Civil Supplies and Consumer Protection, Chennai -5 is authorised to draw the amount sanctioned in para 3 above and disburse the same to the Managing Director, Tamil Nadu Civil Supplies Corporation by means of an account payee cheque for the above said scheme. He is requested to ensure that the amount sanctioned above is utilized in full during 2015-2016 and to send the Utilization Certificate as soon as work is completed.
