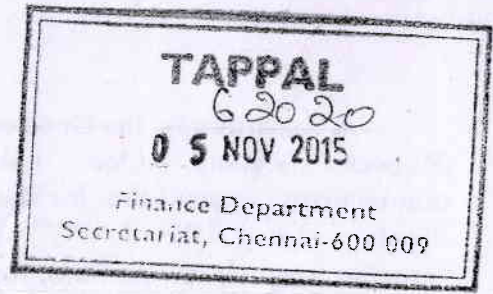

ORDER:

In the D.O. Letter fourth read above, the Member Secretary, State Planning Commission has requested this department to send detailed proposals under "Tamil Nadu Innovation Initiative (TANII) Schemes" for sanction under State Innovation Fund 2015-2016.

2. In the letter fifth read above, the Registrar, Tamil Nadu National Law School, has submitted a proposal namely, "Understanding Your Rights - Law (UYR LAW)" to establish an in-campus Law Studio at a total cost of Rs. 1,55,00,000/- (Rupees One Crore and Fifty Five Lakhs Only) with the aim to create knowledge among the public, the legal content on the basic rights and opportunities envisaged by the Indian Constitution under the State Innovation Fund 2015-2016. In the letter sixth read above, the Registrar(i/c), Tamil Nadu National Law School has further submitted the revised budget for the above project proposal for a sum of Rs.71,52,000/- (Rupees Seventy One Lakh and Fifty Two Thousand Only).

3. In the letter seventh read above, the Member Secretary, State Planning Commission has stated that the State Planning Commission has recommended the proposal of Understanding Your Rights - Law (UYR LAW) for implementation at a total cost of Rs.71,52,000/- (Rupees Seventy One Lakh and Fifty Two Thousand Only) i.e., Rs.5,96,000/- (Rupees Five Lakhs and Ninety Six Thousand Only) per module and the total cost for 12 modules of 30 minutes is Rs.71,52,000/- (Rupees Seventy One Lakh and Fifty Two Thousand Only).

4. Accordingly, the Government hereby accord sanction for a sum of Rs.71,52,000/- (Rupees Seventy One Lakh and Fifty Two Thousand Only) being non-recurring expenditure for the implementation of the scheme of "Understanding Your Rights - Law (UYR LAW)" proposed by the Tamil Nadu National Law School, Tiruchirappalli from the State Innovative Fund 2015-2016 under Tamil Nadu Innovation Initiative (TANII) Schemes (Part-II Schemes).

5. The expenditure sanctioned in para 4 above, shall be debited to the following Head of Account:-

"2202-General Education-03-University and Higher Education-102-Assistance to Universities-II State Plan-KF-Understanding your Rights-Law-(UYR LAW) Schemes under the State Innovation Fund-19-Machinery and Equipments-01-Purchase." (DPC.2202-03-102-KF-1913).

(ii) The expenditure so incurred shall be adjusted by deducting under the following Head of Account:-

"2202-General Education-03-University and Higher Education-902-Deduct-Amount met from State Innovation Fund-JC-Deduct-Amount met from State Innovation Fund-30-Inter-Account Transfers." (DPC.2202-03-902-JC-3001).

(iii) by Contra-debiting from the following fund account-

"8229-00-Development and Welfare Funds-200-Other Development and Welfare Fund-BE-State Innovation Fund." (DPC.8229-00-200-BE-0006)-Outgo.

6. The Registrar, Tamil Nadu National Law School is directed to take immediate action to implement the Scheme namely, "Understanding Your Rights - Law (UYR LAW)".

7. The Director of Legal Studies is authorized to draw and disburse the amount sanctioned in para 4 above to the Tamil Nadu National Law School, Tiruchirappalli.
