#### ORDER:-

The proposal of Additional Chief Secretary/ Commissioner of Revenue Administration for installation of Solar Roof Top Solar Power System Plant (100 KW) at District Collectorate Building in Thoothukudi District has been approved by the Standing Finance Committee for sanction of Rs.90.00 lakh (Rupees ninety lakh only), under Part-II Scheme for the Financial Year 2015-2016 (New Schemes).

The Government have carefully examined the proposal of the Additional Chief Secretary / Commissioner of Revenue Administration and hereby accord sanction for a sum of Rs.90.00 lakh (Rupees ninety lakh only) as non-recurring expenditure for installation of Solar Roof Top Solar Power System Plant (100 KW) at Collectorate Building in Thoothukudi District, Under Part-II Scheme for the Year 2015-2016.

3. The expenditure sanctioned in paragraph 2 above shall be debited under the following head of account:-
