ORDER:

The following project of Tamil Nadu Agricultural University has been approved by the State Planning Commission under Tamil Nadu Innovation Initiatives (TANII) (Second Round) at a total cost of Rs.210.00 lakhs for a period of two years:-

“Pelletization of Forage Crops for Enhancing Livestock Productivity”.

2) The above Project is proposed for Production of cost effective and nutritive fodder pellets from different fodder resources, customization for enhancement of nutritive qualities by adding the energy, protein, mineral supplements etc., and Upscaling and commercialization of validated fodder pellets.

3) The Registrar, Tamil Nadu Agricultural University has, therefore, requested the Government to issue necessary orders for administrative approval for the implementation of the project viz., Pelletization of Forage Crops for Enhancing Livestock Productivity at a total cost of Rs.210.00 lakh for a period of two years (2019-2020 and 2020-2021) and also requested financial sanction for a sum of Rs.200.00 lakh for the first year 2019-20 to implement the above project.

4) The Government, after careful examination, accept the request of the Registrar, Tamil Nadu Agricultural University and accord administrative approval for implementation of the project viz., Pelletization of Forage Crops for Enhancing Livestock Productivity at a cost of Rs.210.00 lakh for a period of two years (2019-2020 and 2020-2021) and also financial sanction is accorded for a sum of Rs.200.00 lakh (Rupees Two Hundred lakh only) for implementation of the above scheme under TANII Project for the year 2019-2020.

5) The amount sanctioned in para 4 above shall be debited under the following Head of Account:-

"2415 - Agricultural Research and Education - 01 - Crop Husbandry - 120 - Assistance to other Institutions - AI - Pelletisation of Forage Crops for enhancing livestock productivity under State Innovation Fund - 309 Grants-in-Aid - 03 Grants for Specific Scheme".

6) The above expenditure shall be met from the State Innovation Fund by deducting under the following Head of Account:-

7) Necessary additional funds of Rs.190.00 lakh will be provided in Revised Estimate/Final Modified Appropriation 2019-2020. Pending provision of such funds, the Joint Director of Agriculture, Coimbatore is authorized to draw the amount sanctioned in para 4 above and disburse the same to the Tamil Nadu Agricultural University. However, the expenditure shall be brought to the notice of the Legislature by **Specific Inclusion** in the Supplementary Estimate 2019-2020. The Registrar, Tamil Nadu Agricultural University is directed to include this expenditure while sending the Budget Proposal for Revised Estimate/Final Modified Appropriation 2019-2020 and also to send necessary draft explanatory notes for including the above said expenditure in the Supplementary Estimates 2019-2020 to Government in Finance (BG-I/Agri) Department at the appropriate time without fail.

8) The Registrar, Tamil Nadu Agricultural University is directed to follow the existing Finance procedures / Government orders while incurring the expenditure under each item from the amount sanctioned in para 4 above. He is also directed to inform the progress of the work and expenditure made every month to Government.

9) This order issues with the concurrence of Finance Department vide its U.O.No.18079/Agri/2019, dated 06.06.2019 and Additional Sanction Ledger No.399 (Three hundred and ninety nine).
