ORDER:-

In the letter 1st read above, the Principal Chief Conservator of Forests has stated that the proposal for assessing Human-Peafowl conflict and developing an action plan to reduce the conflicts in select zones of Tamil Nadu has been placed before the State Planning Commission for sanctioning a sum of Rs.17.48 lakh under Tamil Nadu Innovation Initiatives (TANII) – State Innovation fund for the year 2019-2020 (Round II) in order to reach the following objectives:-

1. Identification of high human-peafowl conflict zones in Tamil Nadu and assess the population of peafowl in identified conflict zones.
2. Evaluate the crop damages and economic loss of agriculture produce due to peafowls in select conflict zones.
3. To assess the effectiveness of searching devices used by farmers to protect the crops.
4. Prepare an action plan for a high conflict zone and propose appropriate management intervention.

2. In the letter 2nd read above, the State Planning Commission has recommended the above project at a cost of Rs.17.48 lakh for a period of one year under Tamil Nadu Innovation Initiatives (TANII) 2019-2020 (Round II). Therefore, the Principal Chief Conservator of Forests has requested to sanction a sum of Rs.17.48 lakh for assessing Human-Peafowl conflict and developing an action plan to reduce the conflicts in select zones of Tamil Nadu under Tamil Nadu Innovation Initiatives (TANII) – State Innovation Fund for the year 2019-2020 (Round II).

3. The Government, after careful examination of the proposal of Principal Chief Conservator of Forests accord administrative and financial sanction for a sum of Rs.17.48 lakh (Rupees Seventeen lakh Forty Eight Thousand) for assessing Human-Peafowl conflict and developing an action plan to reduce the conflicts in select zones of Tamil Nadu under Tamil Nadu Innovation Initiatives (TANII) – State Innovation Fund for the year 2019-2020 (Round II) as annexed to this order.

4. (i) The expenditure sanctioned in para-3 above shall be debited to the following new head of account opened under Demand No.54.01:-

2406 – Forestry and Wildlife – 02 – Environmental Forestry and Wildlife – 110 – Wildlife Preservation – State's Expenditure – AR – Assessing Human-Peafowl conflict and developing an action plan to reduce the conflicts in select zone under State Innovation Fund – 309 – Grants-in-aid – 03 – Grants for Specific Schemes.

5. The Principal Chief Conservator of Forests is the Estimating, Reconciling and Controlling authority of the above new head of account.

6. The expenditure sanctioned in para 3 above i.e., Rs.17.48 lakhs has already been provided in the Second Supplementary Estimates of Demands for Grants for further Expenditure 2019-2020.

7. The Principal Chief Conservator of Forests is authorized to draw and disburse the amount released in para-3 above. He is also requested to ensure that the amount released therein is utilized in full and to send the utilization certificate as soon as the work is completed.
