In the letter read above, the Registrar, Tamil Nadu Agricultural University has stated that the following two Projects of Tamil Nadu Agricultural University have been approved by the State Planning Commission under Tamil Nadu Innovation Initiatives (TANII) Projects for the

- Promotion, Commercialization, Post Harvest Processing and Industrial Application of Annatto (Bixa Orellana I.) as a Source of
- Revitalization of Millets for nutritional security and enhanced productivity - Rs.187.80 lakh (1st year Rs.72.60 lakh, 2nd year – Rs.72.60 lakh, 3rd year Rs.42.60 lakh)
- 2. The Registrar, Tamil Nadu Agricultural University has, therefore, requested the Government to issue necessary orders for administrative Commercialization, Post Harvest Processing and Industrial Application of Annatto (Bixa Orellana I.) as a Source of Natural Dye and an amount of Rs.224.00 lakh may be released for the year 2016-2017 to take up the works according to the technical programme.
