ORDER:

In the reference first read above, the State Planning Commission among others has recommended, for the establishment of "Web based epidemic prone infectious disease notification system for prevention and control of epidemics" in 12 Corporations of Tamil Nadu under the State Innovation Fund in lieu of existing Part-II Schemes (New Schemes) for a sum of Rs. 2.98 crores for the year 2016 – 17 under TANII projects.

- 2. Based on the above recommendation, the Director of Public Health and Preventive Medicine has forwarded a proposal and requested the Government to accord administrative and financial sanction for a sum of Rs. 2,98,00,000/- (Rupees two crore and ninety eight lakhs only) for the establishment of "Web based epidemic prone infectious disease notification system for prevention and control of epidemics" in 12 Corporations of Tamil Nadu under the State Innovation Fund in lieu of existing Part-II Schemes (New Schemes) for the year 2016 17 under TANII projects.
- 3. The Government have examined the proposal of the Director of Public Health and Preventive Medicine in detail and accord administrative and financial sanction for a sum of Rs.2,98,00,000/- (Rupees two crore and ninety eight lakhs only) for the establishment of "Web based epidemic prone infectious disease notification system for prevention and control of epidemics" in 12 Corporations of Tamil Nadu namely Chennai, Coimbatore, Madurai, Salem, Tirunelveli, Thoothukudi, Vellore, Dindigul, Tiruppur, Erode, Thanjavur and Trichy under the State Innovation Fund for the year 2016 17 under TANII projects as detailed below:-
