ORDER:

The Director (FAC), Evaluation and Applied Research Department in her letter read above has proposed to sanction a sum of Rs.62.46 lakhs towards Implementation E-evaluation System under Tamil Nadu Innovation Initiatives Fund for the year 2016-2017, 2017-2018, 2018-2019.

"J Reserve Fund (b) Reserve Fund not bearing Interest – 8229 00 Development and Welfare Funds 200 Other Development and Welfare Fund – BE State Innovation Fund – BE State Innovation Fund (DPC 8229 00 200 BE 0006) (out go)"

5. The Director (FAC), Evaluation and Applied Research Department, is the Estimating, Reconciling and Controlling authority for the above new head of account.

6. The Pay and Accounts Officer (North), Chennai-1 is directed to open the new head of account in his book of accounts.

7. The Director (FAC), Evaluation and Applied Research Department, is authorized to incur the expenditure sanctioned in Para 3 above and she is also directed to follow the procedures and codal provisions while purchasing the items.
