In the reference cited, the Director of Elementary Education has recommended the proposal of the Strengthening Value Education by establishing Story Corners in Primary Schools as follows:

"the aim of education is to bring about all round and holistic development – physical, social, emotional and intellectual. Schools play a vital role in fostering core key values amongst children. NCERT has brought out framework for schools on Education of values which articulates a comprehensive and pragmatic approach to value education in schools. The core value concerns suggested in the framework revolve around Health and Hygiene; Responsibility for Self-development; Responsibility towards one's work/duty; Social Responsibility; Love, Care and Compassion; Critical and Creative Thinking and Appreciation for Beauty and Aesthetics Further NCERT insist on Value Based Integrated Learning (VBIL) wherein all lessons are linked with some values. Based this, Tamil Nadu has developed value in built lessons for all the subjects including language.

- 2, Further the Director of Elementary Education has stated the following:-
- i) At the individual level, fostering values in school students needs to be seen as an investment in building the foundation for lifelong learning and promoting human excellence. The capacity to listen, patience, endurance, cooperation, team work, positive attitude towards study, work and life are hallmarks of a good student. Therefore values promote both academic as well as human excellence.
- ii) Learning through visual experiences such as symbols, drawings, poster, charts, cartoons, graphs, photographs and pictures, and auditory and kinaesthetic experiences compared to verbal mode, are less abstract and more powerful for communication of attitudes and values and forming imagery at the early schooling years.
- iii) Despite many efforts, value education has taken the back seat due to a greater emphasis on academics by both teachers as well as parents and negative influence of media. In schools, it is important to nurture values consciously among children though various strategies.
- iv) Every county has a treasure house of legends and folktales and stories of the exemplary life of great men and women which become a potent source to communicate values. Story telling is a powerful technique as it leaves a perennial impression on the minds of children. India has an age old great tradition of storytelling which occupies prime place in inculcating values.
- v) Stories have always been considered to be the best way to get across an important value based message. In recent years, we have learned that mind has a preference for stories. Persuasive and authentic tales/anecdotes rooted in real world setting communicated in ways that are comprehensible and appealing to students can be especially useful for understanding values.
- vi) Stories and examples of the lives of men of eminence can include the emphasis that greatness achieved is not sudden but through patience, perseverance and practice. The emphasis has to be on drawing lessons directly and or indirectly appropriate to the age of the students. The active participation of students should be elicited which will give them occasion to reflect on various aspects of the lives of great men and the values they embodied.

- vii) This tradition can be reinvented in schools, by establishing Story Corners in Primary Schools, where teachers may use different kinds of **Story Telling Techniques** through which they can teach values. They can use the story books available in their schools. Stories can be narrated using puppets which will really attract the children to a great extent. Different kinds of puppets like cloth puppets, doll puppets, paper puppets, stick puppets etc., may be prepared by the teachers with the help of students.
- viii) The stories can also be made more effective by the concept of Role Plays. Role plays are used as a methodology for inculcating values where the emphasis is not on the acting capabilities but on the projection of ideas/values and analysis of the same. The process of acting helps in better understanding and reinforcing the importance of values.
- ix) Role plays can be conducted according to the age groups his dramatic method may help to kindle the creativity in students. The students may like to take up the characters which they like and do improvisation also. This can be implemented in **five** Middle Schools in a District on a pilot basis.
- 3. The Director of Elementary Education has further stated that the Programme Implementation will be as follows:
 - Programme will be implemented on a pilot basis for 5 Schools in each District. In 160 Schools all over the State.
 - Orientation will be given to five master resource persons from each District and in turn they will impart to all other schools.
 - Effective implementation will be done in phased manner.
 - State level 3 days Orientation Workshop
 - > State level 2 days Reinforcement Workshop
 - > State level one day Follow up Workshop
 - Programme will be carried out to all Primary and Upper Primary children, dividing them into two age groups.
 - \triangleright Age Group -(1) -- Primary (Class I V)
 - > Age Group -- (2) --- Upper Primary (Class VI -VIII)
