Research and Training has submitted the proposals on "Training teachers on Phonetics and instructional strategies for handling English Medium sections in Government Schools, Training of Teachers on the use of Free and Open Source Software (Foss), Orientation to Teachers Handling Virtual Classrooms" under Tamil Nadu Innovation Initiatives for the year 2016-2017 and requested to sanction an amount of Rs.88.20 lakhs, Rs.36.21 lakhs and Rs.21.82 lakhs respectively for the scheme.

The Government accept the proposal of the Director, State Council of Educational Research and Training based on the approval of State Planning Commission and Standing Finance Committee and sanction an amount of Rs.88.20 lakhs, Rs.36.21 lakhs and Rs.21.82 lakhs totally Rs.146.23 lakhs (Rupees One hundred forty six lakhs and twenty three thousand only) to implement the scheme on "Training teachers on Phonetics and instructional strategies for handling English Medium sections in Government Schools, Training of Teachers on the use of Free and Open Source Software (Foss).
