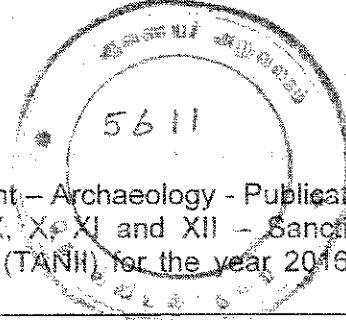

**ORDER:**

The Commissioner of Archaeology, Chennai in the letter read above has sent a proposal to sanction a sum of Rs. 10 lakhs for Publication of Epigraphy Book Titled Tamil Nadu Inscriptions Vol.IX, X, XI and XII, under Tamil Nadu Innovation Initiatives (TANII) for the year 2016-2017.

2. The State Planning Commission has appraised and recommended the above proposal under Tamil Nadu Innovation Initiatives Schemes for the year 2016-17 and the Standing Finance Committee has also approved the above proposal.

3. The Government accept the proposal of Commissioner of Archaeology and sanction a sum of Rs. 10 Lakhs (Rupees Ten Lakhs only) in connection with the Publication of Epigraphy Book Titled "Tamil Nadu Inscriptions Vol.IX, X, XI and XII" at a cost of Rs.8 lakhs (Rupees Eight Lakhs only) and Rs.2 lakhs (Rupees Two Lakhs only) for the purchase of Two Computers and accessories under Tamil Nadu Innovation Initiatives (TANII) for the year 2016-2017 as approved by the State Planning Commission.

4. The expenditure sanctioned in para 3 above shall be debited to the following head of account:-


